

## **Mobius' Privacy Policy**

In this Privacy Policy, “we”, “us”, “our”, and “Mobius” refer to Mobius Bionics LLC. “You” refers to a user of this Mobius website (“Site”).

This Privacy Policy (“Policy”) applies to any personal information that you supply to us when visiting this Site. Mobius will use information gathered through this Site only in accordance with this Policy.

By using this Site, you consent to our collection and use of your personal information as described in this Policy.

This Policy is designed to assist you in understanding how we collect, use and safeguard the personal information you provide to us and to assist you in making informed decisions when using our Site.

We reserve the right to change this Policy. We will post the changed Policy at this Site.

Mobius is the sole owner of the information collected through this Mobius Site. We do not sell, share, or rent this information to others.

The information we collect through this Site may be categorized as follows:

- Passive traffic information is non-personal information that helps us track the success and content of our Site. We use IP addresses to analyze trends, administer the Site, track user movement and gather broad demographic information for aggregate use. None of the traffic information is ever connected to specific individuals.
- Voluntarily supplied information is information that users give us while using our Site. This information falls into the following categories:
  - General demographic information is non-personal information, such as state and country of residence. This helps us to identify our user groups and customize the Site according to their needs.
  - Personally identifiable information is any information that might identify a specific person (such as name, email address). Users leave personally identifiable information with us to enable us to contact them to answer questions, requests, and inquiries. Personally identifiable information is only collected voluntarily at this Site.
  - Personal health information is information about the health status or health history of an individual. It is not necessary to supply any personal health information in order to use this Site. Personal health information is only collected voluntarily at this Site.

Mobius may use the information collected at this Site for the following purposes:

- Site traffic reports - these include general non-personal information on the traffic and us-

age of the Site. Traffic reports are standardized server reports that show general trends and behavior and cannot be connected to any individual or computer. Information on traffic is used to measure the success of the Site and its content.

- To provide information to you or otherwise contact you.

We do not share your personally identifiable information or personal health information with unaffiliated third parties unless you authorize that sharing.
